By appointment of President Clinton, Mr. Ickes served as Director of Summit Affairs for the 1997 Denver Summit of the Eight, the meeting of the heads of state of eight of the world's leading economic nations, formerly known as the "G7 Economic Summit." He also managed President Clinton's 1992 New York Primary campaign. Mr. Ickes directed the 1992 Democratic National Convention on behalf of the Clinton/Gore campaign and served as Deputy Chair of the Democratic National Committee under Chairman Ron Brown until the 1992 general election.
