Matthew A. Marcucci handles complex disputes for clients that run the gamut from publicly traded, multinational companies to middle-market and small businesses. He has broad experience in a variety of commercial matters, and has litigated actions involving claims alleging breach of contract, fraud, business torts, and intellectual property violations, as well as shareholder disputes and corporate dissolution proceedings, among others.

Some of his representative matters include the following:

- Represented a healthcare billing and collections company with dozens of significant clients in Long Island and the greater New York City region in multiple litigations, including obtaining judgment in the company's favor worth nearly \$3 million.
- Represented and counseled one of the world's largest costume designers, manufacturers, and distributors, including in adversarial proceedings arising within the company's Chapter 11 case. For this engagement, Meyer Suozzi won the Chapter 11 Restructuring of the Year Award for small to middle-market companies at the Global M&A Network's 13th Annual Turnaround Atlas Awards.
- Represented one of New York's Native American Indian nations in a complex litigation over the nation's property rights, including the nation's right to control its land in eastern Long Island. In March 2021, the Appellate Division of the Supreme Court of the State of New York, Second Department, ruled in favor of the nation in an opinion available [here](#).
- Represented an information-technology and telecommunications company with operations in more than thirty countries in multiple litigations at the trial - and appellate-court levels, including defending against breach of contract and business tort claims.
- Represented a public utility company in connection with a land dispute involving multiple stakeholders with complex property interests, including prosecuting a litigation to protect the utility's rights and assets.
- Represented a leading New York lobbying firm and its principal in litigation, including briefing and arguing a successful summary-judgment motion that resulted in the dismissal of claims alleging fraud and seeking punitive damages.

Matthew has received numerous accolades for his legal successes. In February 2020, Matthew received the Long Island Business News' 40 Under 40 Award, which honors outstanding members of the business community on Long Island who are 40 years old or younger.

Matthew remains enthusiastically involved in the legal community, and has taught CLEs and authored publications on topics of interest. In November 2020, Matthew served as one of the presenters of the Theodore Roosevelt American Inn of Court's CLE, "Litigating in a Post-COVID-19 World, and Contract Obligations in a Post-COVID-19 World."
